The veterinary office is located north of the intersection of State St (E-W road) and Alpine Rd (N-S road) on the east side of Rockford, IL, approximately 16 minutes from the test site. Go west on Harlem Rd to Alpine Rd, south on Alpine Rd about 5 miles to Maray Drive. Go west ½ block on Maray Drive to the **Animal Emergency Clinic** on the right.

Do NOT send entries by any method requiring a signature for delivery.

NOTE: Certifications statement must be sent with entry forms for dogs that have not passed an AKC Tracking Dog test.

ALL CANCELLATIONS of entries must be made in writing to the Test Secretary & received prior to the stated date and time of closing of entries.

CLOSING DATE: Wednesday March 21, 2012 at 12 noon at home of test secretary.

DRAW for ENTRIES: will be held that evening at 7:00pm at

Wendy’s 370 US Hwy 45, Lindenhurst, IL 60046 to determine which dogs will participate. The public is invited.

Entries will be notified by phone of their status as soon as possible after the draw. Entrants may also call the Test Secretary at 847-356-2986 from 8:30pm until 9:30 pm on **Wednesday March 21, 2012**. Non-participating alternates’ fees will be returned within one week after the test.

DRAW FOR TRACKS: 8:15 AM for TD at the Olson Recreation parking lot. First track will run immediately after draw, conditions permitting.

INCLEMENT WEATHER: In the event of extreme weather conditions the Club may take such action as necessary to protect the health and safety of the dogs, handlers and judges, including postponement or cancellation of the test.

LOCATION: Rock Cut State Park is located northeast of Rockford, IL.

It straddles I-90 and is bordered on the south by Harlem Road, on the north by Hwy 173, and to the west by Perryville Road. Entrance to the Olson

Recreation Area is on Harlem Road. Exit I-90 at Riverside Blvd, go west to McFarland Rd., turn right on McFarland and go north to Harlem Rd. Turn right and follow Harlem Road east over I-90 to entrance. We will meet in the beach parking lot.
